



# CALTRAIN **ELECTRIFICATION**

## CESAR CHAVEZ LANE CLOSURE NOTICE | March 2024

### **UPCOMING ACTIVITIES AND ACCESS IMPACTS**

Beginning on Monday March 4 until March 9, Caltrain will be installing conduit across Cesar Chavez Street, requiring a temporary closure of one side at a time of Cesar Chavez Street at the Mississippi Street intersection to vehicle traffic on Monday-Saturday.

#### From March 4 to March 9 between the hours of 9 pm and 7 am there will be a temporary traffic closure of one side at a time of Cesar Chavez street at the Mississippi Street intersection.

Illuminated and directional signs will direct vehicles from the closed side of the intersection to the opposite side of the intersection. Only one side will be closed at a time.

A sample lane diversion plan is provided at the bottom of this notice.

#### **CONSTRUCTION ACTIVITIES**

During the temporary access closures, crews will install a conduit for the Caltrain Electrification Project. Work will consist of excavation, pulling of conduit, and returning the street to previous conditions.

Caltrain has established a dedicated project hotline and email for residents concerned about these potential impacts.

#### **PROJECT OVERVIEW**

Over the last decade, Caltrain has experienced a substantial increase in ridership and anticipates further increases in ridership demand as the Bay Area's population grows. Caltrain Electrification, scheduled to be operational by 2024, will electrify and upgrade the performance, operating efficiency, capacity, safety and reliability of Caltrain's commuter rail service.

Caltrain electrification is a key component of the Caltrain Modernization Program and consists of replacing diesel-hauled with an electric train system for services between Fourth and King Street Station in San Francisco and the Tamien Station in San Jose. The project will include the installation of new electrical infrastructure and the purchase of electric trains.






