Re: Local Policy Maker Group Selection Vice Chair - ACTION ITEM

Background:

The Local Policy Maker Group (LPMG) was created in October 2012 as the venue for local policy makers to discuss and inform decisions on the Caltrain Modernization (CalMod) Program, specifically implementation of the Advanced Signal System and Peninsula Corridor Electrification Project.

LPMG agenda items are identified to provide timely input to the Caltrain Board in their actions and discussions regarding the CalMod Program. The CalMod Executive Director provides regular updates to the Caltrain Board on the LPMG meeting discussions.

In January 2014, at the request by the City of Palo Alto and Town of Atherton, the topic of the LPMG structure was agendized. During the meeting, the role and structure of the LPMG was discussed and the group reached consensus that the LPMG should move forward with the current structure but continue to monitor its effectiveness and be open to making changes as necessary.

In January 2016, the LPMG started receiving alternating updates (on separate months) from Caltrain staff on the CalMod Program and the California High-Speed Rail Authority (CHSRA) staff on the Blended System Program.

At the request of several LPMG members, at the April and June 2016 meetings, the role / structure of the LPMG was agendized. After much discussion, several changes to the role / structure of the LPMG were decided at the June 2016 meeting. The changes are reflected below:

• The LPMG would be able to vote on agenda items. Not all items require action, and the action, individual votes or consensus positions, may vary depending on the item.

- A Caltrain Board member would be the Chair of the LPMG for both CHSRA Blended System and Caltrain CalMod LPMG meetings. The Chair position is tied to the role on the Caltrain Board, not to the individual Board member.
- A Vice Chair would be selected from the LPMG membership. (Note: It was determined at the beginning of each year, the the LPMG would vote on a Vice Chair)

Re: Caltrain Proposed Weekday / Weekend Service Changes

Caltrain is proposing weekday and weekend service changes to accommodate construction activities in spring/summer 2017 related to the <u>Peninsula Corridor Electrification Project</u> (PCEP), a key component of the Caltrain Modernization program and other Capital Projects that will occur simultaneously with electrification – Los Gatos Bridge, 25th Ave. Grade Separation, and South San Francisco Rehab projects.


The proposed weekday timetable changes have almost no changes to the peak hour service. There are small departure adjustments, with added service to several trains. The weekend timetable will be changed from service every 60 minutes with Baby Bullet service to 90 minute schedules with Baby Bullet service. Caltrain has been coordinating these changes with regional transit partners such as Muni, BART, and VTA.

The proposed weekday timetable changes will take effect on April 10, 2017 and the weekend changes will take effect in summer 2017.

Weekday Service Changes

- Proposed Effective Date April 10, 2017
- Detailed Summary
 - Added 6 stops (Sunnyvale, California Ave, San Carlos, San Mateo, Burlingame, San Bruno) Train 305
 - Added Dwell Time to Top High-use Stations Peak Hours
 - Added stops at Santa Clara station to Trains 262 & 272 to improve Capitol Corridor and ACE connections
 - Minor revisions for clock face departures
 - Separation Southbound AM Bullet Trains 312 & 314 and 322 & 324; Revised Train Numbers and Departure Times

Weekday Service Changes (cont'd)

- Detailed Summary (cont'd):
 - Provide hourly service to Tamien in the reverse peak
 - Eliminate Tamien Station service due to very low ridership:
 - AM Reverse Peak Trains: 208, 218, 228
 - PM Reverse Peak Trains: 263, 273, 283, 287
 - Add Tamien Station service for various trains:
 - AM Peak Trains: 310, 320, 330
 - PM Peak Trains: 289
- Departure times adjusted during off-peak to enable all train meets to occur at control points to accommodate construction work windows



Weekend Service Changes

- Proposed Effective Date Summer 2017
- Detailed Summary
 - Local service headways 60 mins to 90 mins
 - Saturday reduced from 36 to 28 trains per day
 - Sunday reduced from 32 to 24 trains per day
 - Keep weekend bullets (2 in each direction)
 - Keep range of service (trains & shuttles)
 - Revised Train Numbers
- Weekend Service Reduction is "Major Service Change" under 2016 Title VI Program
 - ≥ 25% reduction of total revenue train miles per day for any service day of the week
