- Objective: Campaign to increase ridership by targeting new and current caltrain riders
- Timing: Summer
- Tactics: Press release, website content, social media channels and paid digital media.
- Big push in May to align with Bike to wherever day (bike month in general)

• Most Bike/Scooter user ride Caltrain 3-4 days (commute days) push for weekend usage

Public comments

Nicole Rodia commented on including information about new eLockers.

CMF (Chris) commented on the obstacles to using a bike or scooter is safety of the roads nearby and the Brisbane Station elevators not working since December.

The Committee members had a discussion and staff provided further clarification in response to the Committee comments and questions, which included the following:

- Committee reaching out to local jurisdictions with support of projects encouraging road safety improvements to stations
- Suggested promoting bikes and Caltrain by connecting to adjacent infrastructure where people are doing leisure biking, live events
- Collaborating with local bike organizations to c understand where people bike most and at what stations, allowing for more education and engagement
- Looking for leisure locations in between stations to inspire riders
