New AI technology RailSentry has been deployed at Broadway in Burlingame, and will soon come to Churchill Avenue in Palo Alto.

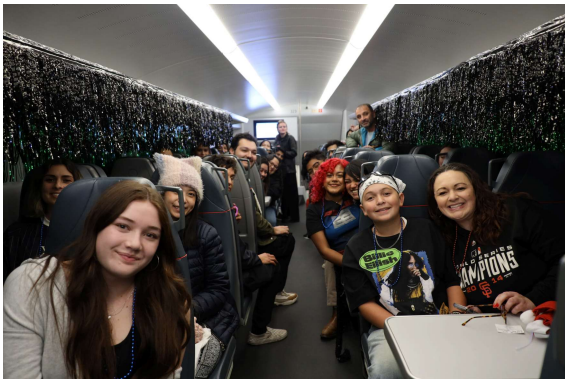

Fans heading to the Dec. 10 Billie Eilish Concert at SAP Center got to ride in style on Caltrain's dedicated Billie car, a first for the agency.

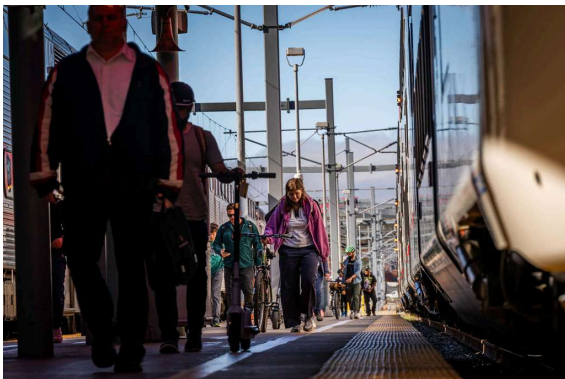
