Dear Alyssa,

Thank you for reaching out and sharing your concerns regarding the recent tree removal and the subsequent increase in noise near Shadowgraph Drive. We understand how the removal of these trees has affected the neighborhood, and I'd like to provide some context and address your concerns.

The removal of the trees was necessary to mitigate the risk of fallen branches or trees damaging infrastructure or posing a safety hazard, and to ensure proper clearance for the Overhead Contact System (OCS), a key component of our new electrification project.

As you may know, we had previously removed eucalyptus trees after three fell and damaged the sound wall. Our goal is to ensure the safety of the public, and the remaining eucalyptus trees were also removed due to the risks they posed.

In response to the removal, the electrification project has already planted new trees as part of a mitigation plan, and these are still growing.

Thank you again for bringing this to our attention. We will keep you updated on any developments and welcome any further suggestions or questions you may have.

Dear CalTrain Public Support Team,

I am writing to express concern regarding the recent removal of trees near Shadowgraph Drive in San Jose, California across from the Tamien hub. These trees previously provided a buffer between mine and our neighbors' properties and the trail tracks and freeway, significantly reducing both noise and visibility of traffic and trains. Since their removal, there has been constant and excessive noise at all hours, with trains and other traffic frequently using their horns during both day and night, causing severe disruption to nearby residents.

This increase in noise is not only disturbing but also impacts the overall quality of life for neighbors in the area. Additionally, the absence of this natural barrier is likely to lower our property values for homes that now directly border this railway.

I would like to inquire whether there are plans in place to replant trees or establish an alternative barrier to mitigate the noise and restore privacy. If no such plans are currently in place, I would appreciate guidance on next steps required to initiate the process of installing a new barrier in the near future.

Thank you kindly for your attention to this matter. I look forward to your response and any information you can provide on potential solutions.
